MEMORANDUM FOR WALDORF SOCCER CLUB

FROM: WALDORF SOCCER CLUB EXECUTIVE BOARD

SUBJECT: **Travel Player** Financial Aid Program

1. The Waldorf Soccer Club is committed to ensuring that any child with the desire, commitment, and ability to play soccer has the opportunity to participate regardless of financial ability. This policy establishes the Club's Financial Aid Program. **Note:** Financial Aid for Recreational and Classic Program Players is available through the Waldorf Soccer Club's **James E. Maples Memorial Scholarship Fund** found at [www.waldorfsoccer.com](http://www.waldorfsoccer.com).
2. Subject to the availability of funds, the Waldorf Soccer Club shall offer financial aid to those members that demonstrate a need or financial hardship. The decision to make any award, the amount thereof, and the beneficiaries shall be made on a defined set of decision factors which are consistently applied. All award decisions are made at the sole discretion of the Waldorf Soccer Club Financial Aid Committee. The application information will be kept confidential within the Waldorf Soccer Club Financial Aid Committee and the Club Treasurer.
3. Applications

Completed applications (with supporting documentation) for financial aid may be mailed to Waldorf Soccer Club Financial Aid, P.O. Box 314, Waldorf, MD 20604. Applications may also be e-mailed with scanned supporting documents to the Waldorf Soccer Club Treasurer at [treasurer@waldorfsoccer.com](mailto:treasurer@waldorfsoccer.com). Incomplete applications will result in disqualification for aid.

4. The Club awards up to \$500 annual financial assistance to **Travel Program** players.
  - a. Travel players that are awarded financial assistance will agree to participate in the Waldorf Soccer Club travel program for the both the fall and spring sessions.
  - b. It is expected that travel players receiving aid awards will participate in fund-raising activities to assist with funding the remainder of their soccer expenses.
  - c. **Award decisions for travel players will be made during July. Applicants will be notified of aid decision by July 31, 2017.**
  - d. **The program financial aid application deadline will be July 15, 2017.**

## 5. Eligibility

- a. Any Waldorf Soccer Club Travel Player is eligible to apply for financial aid.
- b. Qualification is primarily based on verified family income.
- c. To be eligible, a family's aggregate household Adjusted Gross Income (AGI - line 37 on Federal tax return Form 1040) **MUST NOT EXCEED** the most recently published Median Household income estimate for Waldorf, MD by the State of Maryland Dept. of Planning Data Center.
- d. **For 2017-2018, the maximum AGI is set at \$ 86,362.**
- e. Other factors such as unemployment or other financial hardships may be considered by the Financial Aid Committee.
- f. Children of Waldorf Soccer Club Executive Board and Financial Aid Committee members are not eligible.
- g. Families of applicants receiving an aid award will be required to provide up to twenty hours volunteer service such as Concession stand, merchandise tent etc, to Waldorf Soccer Club each soccer year (July through June). Those applicants that do not fulfill this requirement be ineligible for future aid awards.
- h. Multiple children in the same household may also apply for aid. Please include a separate application for each child, including IRS documents for each The Financial Aid Committee **MAY** award aid to more than one child in a household if they deem appropriate and within the committee's assigned aid budget. Families may or may not receive aid for all children applying.

## 6. Application Process

- a. Applications for financial aid are available online (attachment 1 – see below) and must be completed and returned to Waldorf Soccer Club by the above indicated deadlines.
- b. A signed copy of the most recent Federal tax return on Form 1040 (or applicable form) for both parents and/or guardians of the applicant (supporting schedules and attachments are not required, unless requested) must be filed with the financial aid application.
- c. The applicant **MUST** appear as a dependent on the parents' IRS 1040.
- d. Additional forms (i.e. W-2's, 1099's, etc) may be required by the Financial Aid Committee.
- e. Applicants will still register through the Club's on-line registration system and remit the non-refundable \$100 deposit. This will ensure the children will be reserved a slot, pending decision of the Financial Aid Committee.
- f. Applications are **NOT** considered complete until all required documents have been submitted.
- g. Incomplete applications will not be considered by the committee.

## 7. Award Process

- a. If there are fewer applications than budgeted, the Club Treasurer will award all applicants without assembling a committee.
- b. If there are more applications than budgeted, applications will be evaluated by the Financial Aid Committee.
- c. The Financial Aid Committee will notify the Waldorf Soccer Club Treasurer of all financial aid decisions.
- d. Notification of aid awards shall be made via telephone and/or email to each applicant by the Waldorf Soccer Club Treasurer.

8. No cash payments will be made to any player or their family.
